

ARMED BUSINESS ROBBERIES ON THE INCREASE IN RUSTENBURG

ARMED ROBBERY AT PLATINUM SQUARE

Rustenburg – “Four security officials on duty, patrolling the Platinum Square mall on Tuesday morning, 11 April 2017, were confronted by two unknown African males behind Checkers,” Captain Elsabé Augoustides, police spokesperson, said. The suspects were wearing balaclavas and held the security officials at gunpoint. They were instructed to lie down, and their hands and feet were tied. The security officials were robbed of their radios.

The suspects then proceeded to Bargain Books where they gained entry by force. The wall was damaged with a hammer and grinder. The safe was grinded open and an undisclosed amount of cash was robbed. Damages amount to about R20 000. The suspects fled on foot. The suspects also tried to access the Capitec bank next door to Bargain Books.

RUDAN FILLING STATION, ARMED ROBBERY

Rustenburg – “The Rudan filling station (Engen garage) was robbed on Sunday evening, 9 April 2017, at approximately 21h30,” Captain Elsabé Augoustides, police spokesperson, said.

After the last customers of the kiosk left, three unknown suspects entered the shop, wearing balaclavas. They were armed with firearms and a knife.

The employees working at the kiosk and the petrol attendants on duty were held at gunpoint – and warned not to make alarm. The cashregister (till) was emptied by the intruders. The employees were also robbed of their cell phones. The suspects fled on foot, and no arrests have been made thus far.

OOSMEY MOTORS ROBBED OF 26 BATTERIES

Rustenburg – Twenty-six (26) car batteries and a cell phone was stolen from Oosmey Motors in Kruger street on Friday, 7 April 2017, Captain Elsabé Augoustides, police spokesperson, reported.

At the time, at about 03h30, the company's security official was sitting inside his vehicle as it was raining. He noticed three unknown males approaching him, wearing balaclavas. He tried to flee from the vehicle, but they pointed an unknown object against his head. The suspects tied the security official to the seat of his vehicle. He heard the suspects opening the workshop and later the sound of a moving vehicle. As he managed to untie himself, he noticed that the suspects stole 26x car batteries and a cell phone.
