If you live, work or farm close to a Transnet Pipelines underground high pressure petroleum or gas pipeline, it is VITAL that you respect and adhere to the servitude conditions. These conditions also refer to permission to occupy areas. The servitudes vary in width and there are white markers placed in the centre of the servitude. It is important to stay well clear of the markers and ensure that your actions do not affect the safety and integrity of the pipeline's. Digging near the pipeline markers may lead to

severe consequences including personal injury. If you violate the servitude conditions you will be prosecuted and could also be held liable for the associated costs including environmental clean-up costs. Don't take the risk!
