

LOCAL WILDLIFE HERO VIE FOR TOP HONOUR

Hartbeespoort – Kerri Wolter, founder and CEO of VulPro in Hartbeespoort, was announced as a nominee for the world’s leading animal conservation award on 12 September. These wildlife heroes vie for the top honour and \$250,000.

Wolter manages vulture research on disease and nutrition, facilitates breeding census across colonies and coordinates wild captures for tagging; manages rehabilitation and captive breeding centres with more than 150 non-releasable birds.

As 2,200 zoological professionals from around the world descend on the Circle City for the Association of Zoos and Aquariums’ (AZA) annual conference, Indianapolis Prize officials announced 32 global leaders in the field of animal conservation as Nominees for the 2018 Indianapolis Prize on 12 September.

Regarded as the world’s leading award for animal conservation, the biennial Prize spotlights the stories and accomplishments of brave men and women whose work not only saves species of this generation, but shapes future populations and ecosystems.

“The 2018 Indianapolis Prize Nominees represent many of the most significant and accomplished wildlife conservationists in the field today,” said Michael Crowther,

president and CEO of the Indianapolis Zoo, which initiated the Indianapolis Prize as part of its core mission. “They are protecting species and creating successful conservation methods that ensure future generations will live in a flourishing and sustainable world. We applaud their accomplishments and encourage individuals, organizations, companies, and governments to join them in advancing animal conservation.”

Nominees hail from countries across the globe, focused on both iconic and unique animals, from primates and marine mammals to reptiles and birds. This year brings a more significant collection of individuals studying species of Asian ecosystems, including critically endangered orang-utans, snow leopards, tigers and slow lorises.

These finalists will then be honoured at the next Indianapolis Prize Gala presented by Cummins Inc.,

to be held 29 September 2018. The winner of the prize will receive an unrestricted \$250,000 cash award while the five finalists will each receive \$10,000. In addition to the monetary award, the winner will receive the prestigious Lilly Medal, a cast bronze medal showcasing the relationship between people and the natural world, a fitting remembrance to the individuals creating positive outcomes for species.
