Jaco's life was forever changed when he suffered devastating injuries including a hip fracture and a C2 neck fracture in a car accident on 24 March 2018. More than a year later and Jaco is safely back home with his family. He still has a long and expensive road to recovery ahead of him and the goal of this fundraiser was to help him raise funds for his aftercare.

Newrak Impala Rugby Club's field was packed with players competing for the touch rugby champs title. It was touch and go for a while but the team 'Try Time' proved their spirit and emerged as the winners!

NOTICE IN TERMS OF THE NATIONAL BUILDING REGULATIONS AND STANDARDS ACTS 103 OF 1977: BURNT HOUSES IN RUSTENBURG CBD

During February 2018 the community of Rustenburg protested against the illegal activities which took place in suspected houses and guest houses around Rustenburg. 12 houses were burnt by protesting and angry community in Rustenburg. The cause of the protest and the ultimate burning of these houses were illegal activities that allegedly took place in such houses like prostitution, drugs, dealings and human trafficking.

The below listed houses are some of the burnt houses:

NO.	PROPERTY OWNER	PROPERTY ADDRESS
1.	Hammond HR	19 A Leyds street, Rustenburg East, Erf 2/666
2.	GOMES A	15A Kruger Street, Rustenburg East, 5/630

These houses are classified and have become a nuisance to the community therefore; a notice is hereby issued in terms of the above-mentioned properties to collect their correspondences relating to the demolishing of the buildings within 14 days of the publication of this notice.

Should the owners of burnt houses not avail themselves and remedy the nuisance, they will be charged, and the houses shall be demolished. Costs of the demolition shall be borne by the affected house owners.
