SIBANYE-STILLWATER'S RUSTENBURG AND MARIKANA WAGE NEGOTIATIONS UNDERWAY

Rustenburg – Sibanye-Stillwater confirmed that it has received notice that the Association of Mineworkers and Construction Union (AMCU) has referred the current wage negotiation process for the Rustenburg and Marikana operations to the Commission for Conciliation, Mediation and Arbitration (CCMA) for conciliation.

This is another stage in the negotiation process which follows internal dispute resolution processes. The Company continues to engage constructively with AMCU in an attempt to conclude a fair and sustainable wage agreement. The notice of referral of the dispute requires CCMA to appoint a commissioner who will assist the

parties in an attempt to resolve the dispute within the required statutory period of 30 days.

COCAINE AND FIREARMS RECOVERED IN NW

NW – Cocaine worth an estimated R30,000 (street value), firearms and vehicle parts, were seized by the police on Friday 27 September in three separate incidents.

Eighteen suspects were arrested and have appeared before courts to answer to the illegal possession of drugs, firearms and other charges related to the incidents.

In the first incident, 12 undocumented individuals aged 22 to 52, were arrested at a roadblock along the R30 road between Orkney and Bothaville. This came after police discovered three firearms and ammunition while searching the suspects' vehicle. "Three suspects, aged 20 to 32, were also arrested

at the same roadblock after they were found in the possession of 12 bricks of crack cocaine," said police spokesperson colonel Adéle Myburgh.

In the third incident, two suspects were arrested in Soshanguve for their alleged role in a house robbery in Klippat. Police confiscated an LCD television, bolt cutter, gloves and clothing while searching the trio.

"Further investigations led the police to another suspect, who is linked to a case in which a car was stolen. The 23-year old suspect was arrested while a Volkswagen, an engine, bumpers, a gearbox, seats and other car parts were recovered," colonel Adéle concluded.

PRISONERS ESCAPE FROM KLERKSDORP COURT

Klerksdorp – Five men facing charges ranging from armed robbery, the illegal possession of unlicensed firearms to attempted murder, escaped from the Klerksdorp Regional Court on Thursday 17 September, shortly after their court appearances.

Sibuso Sibeko (40), Tebogo Molefi Ntchenane (35), Bongani Edwin Mkhwanazi (51), Sithembiso Mthembu (43) and Tshepo Seboko (37) staged the escape as they were being escorted to the court's holding cells.

The five, who were arrested for armed robbery in November 2015, are also due to face trial for hijacking, possession of stolen vehicles and attempted murder. Spokesperson for the Hawks in the North West, captain Tlangelani Rikhotso, said: "After their court appearance, the suspects were taken to the holding cells. One of the accused drew a firearm and pointed it at a police officer. The officer managed to escape and the five opened the steel door and escaped."

A reward is on offer for information regarding the whereabouts of the five suspects.

"Information received will be treated in strict confidence and we urge the community not to approach the suspects as they are considered armed and dangerous," Tlangelani urged.

The five were arrested in 2005 in Wolmaransstad for stealing an Izulu bakkie after threatening the driver, a security manager at a local mine, with a firearm. They drove away with diamond gravel that was loaded in the vehicle. The suspects were eventually arrested through a collective effort involving the community and the police after footage of the armed robbery was widely circulated on social media platforms.
