BIRDS OF VIETNAM BirdLife Rustenburg

Rustenburg – After being isolated from the birding and travelling world for so long, Vietnam has become one of the key destinations on the world birding travel map. Apart from the birding, Vietnam also has a very rich culture, a wide diversity of people and great scenery, making it worthwhile to visit for both birders and non-birders alike. Vietnam, being 1,600km long with over 3,000km of coastline, has a wide variety of habitats and seasons. Geoff Finney and Leslie Ryan, two of BirdLife Rustenburg's most experienced birders, recently had the opportunity to visit this fascinating country. Geoff will be sharing their experience and photos with the club. This will take place on Monday, 16 September at Methodist Church on the corner of Brink and Schuurman streets at

19:00. A charge of R20 from non-members is payable. ** Roodekoppies Dam, 30 kilometres north of Brits, is the destination for the club's outing this month. This will take place on Saturday, 21 September. The dam is famous for the returning African Skimmer that has visited for many seasons. Approximately 350 birds have been seen with specials such as the Great Crested Grebe, Osprey, Double-banded Sandgrouse, Ashy Tit, Barred Wren- Warbler, Great Sparrow and Black-faced Waxbill. A wide variety of water birds and waders will also be seen.
