NOTICE OF THE PROPOSED CONSTRUCTION OF TWO NEW VENTILATION SHAFTS AND ASSOCIATED INFRASTRUCTURE AS WELL AS THE UPGRADING OF AN EXISTING BUS AND TAXI TERMINAL AT THE RUSTENBURG PLATINUM MINE (AMANDELBULT SECTION), LIMPOPO PROVINCE

Notice is given in terms of Regulation 32 of GNR 326 (07 April 2017) published under section 24 and 24D of the National Environmental Management Act (No. 107 of 1998) (NEMA) (as amended) for submission of an application for Amendment in terms of the Part 2 Amendment Process described in Regulation 31.

BACKGROUND AND LOCATION
The Rustenburg Platinum Mine (Amandelbult Section) (Amandelbult) is situated approximately 17km south of Thabazimbi, and 24km north east of Northam, in the Thabazimbi Local Municipality, Limpopo Province. The Amandelbult Complex consists of the Tumela and Dishaba established mines, situated on the north-western limb of the Bushveld Complex. The following projects are being proposed at the mine:

- **Ventilation Shaft Project:** Amandelbult has identified the need to improve mining efficiency and productivity at its operations. As an operational forecast, increased ventilation will therefore be required. It is proposed that 2 ventilation shafts (Upcast and Downcast shafts) and associated infrastructure are constructed North East and South East of Dishaba Main.
- **Bus and Taxi Terminal:** Amandelbult also aims to upgrade the existing Tumela Mine bus and taxi terminal, which is currently an informal area where busses, taxis and private vehicles transfer personnel working at Tumela Mine.

The requested amendments do not trigger listed activities in terms of GNR 327, 325 or 324 of April 2017. However, the activity will result in a change in scope of the valid Environmental Management Programme (EMPR) and will potentially result in an increased level or nature of impact. As such, a Regulation 31 Amendment Process in terms of Part 2 of the EIA Regulations (GNR 326) of April 2017 is applicable.
