**Brits** – Five suspects who appeared before the Brits Magistrates' Court on charges of illegal possession of firearms and ammunition, as well as possession of housebreaking implements, have been denied bail. Prosper Ndebele, Kingdom Makgetha, Given Shumba, Ezekiel Matlala and Thulani Sithole, who made their second court appearance on Friday 28 August, was arrested while allegedly planning to rob a business and homes near Brits.

"The suspects applied for bail but was denied. They were remanded in custody until their next court appearance on 27 November," police spokesperson colonel Adèle Myburgh said.

A community tip-off to the police by members of the Bokfontein community led to the arrest of the suspects on Friday 21 August, while they were planning business and house robberies in Mooiooi. Acting on information, police members of the Brits Tactical Response Team (TRT) and the Rustenburg Flying Squad located and cornered a white Nissan minibus that the suspects were travelling in.

A huge bolt cutter, hand gloves, a baton and pepper spray were among the housebreaking implements that were also found inside the vehicle during the search.

## HOUSEBREAKING SUSPECTS ARRESTED

**Brits** – A tip-off to the police by members of the Bokfontein community led to the arrest of five suspects who were allegedly planning to rob a businesses and homes near Brits.

Prosper Ndebele, Kingdom Makgetha, Given Shumba, Ezekiel Matlala and Thulani Sithole have since appeared before the Brits Magistrates' Court on charges of illegal possession of firearms and ammunition as well as possession of housebreaking implements. Police spokesperson colonel Adèle Myburgh said the five were apprehended on Friday 21 August in Bokfontein outside Brits after police were informed about their intentions to commit business and house robberies in Mooiooi.

Acting on this information, police members of

the Brits Tactical Response Team (TRT) and the Rustenburg Flying Squad located and cornered a white Nissan minibus that the suspects were travelling in. "The vehicle and the occupants were searched. Consequently, a revolver was found in possession of one of the accused. A 9mm pistol and a magazine loaded with ammunition was also found in the minibus," Myburgh said.

A huge bolt cutter, hand gloves, a baton and pepper spray were among the housebreaking implements that were also found inside the vehicle during the search. "All six occupants were arrested and further investigations to determine if the suspects may be linked to other crimes are being carried out," Myburgh concluded.

## CARD SCAMMERS USING WHITE FORD AND BLACK AUDI

**Rustenburg** – Police in Rustenburg have warned community members to be on the lookout for criminal syndicates travelling in a white Ford sedan or a black Audi. The suspects have been scamming innocent people at ATMs and robbing them of their money at various shopping malls.

This warning follows an increase in the number of ATM fraud cases that have been reported to the police by victims who have lost their hard-earned money to criminal syndicates operating in the central business district (CBD). In one of the cases that were reported to the police, a victim lost R13,000 to criminals.

Police have since established that four or five of these criminals have been travelling in a white Ford sedan (registration plate: JJ69NSGP).

"We have determined that it is a rented vehicle. There is also a silver Polo of which the registration number has been removed, is also said to be involved," captain Elsabé Augoustides said.

In another incident, a person was robbed of a substantial amount of money at the Rustenburg

Square Complex. Police have gathered that the suspects were travelling in a black Audi (registration plate: CS57FRGP).

Police spokesperson captain Augoustides appealed to those who frequent malls, shopping complexes and other busy areas to always assess their surroundings, especially before making any financial transactions. "Please be on the lookout whenever you are at the ATMs, especially in the Rustenburg CBD."

"If you have your bank cards with you, please be very careful of card scammers. They are operating in the vicinity of the Biblio Plaza, the Rustenburg Plaza as well as the Pick and Pay parking area close to the BP Garage," she added. The criminals, who usually operate in groups, either rob victims of their bank cards or scam them while they are withdrawing money. She advised those who have lost their money to scammers to report it to their nearest police station.

## BIKERS UNITE AGAINST FARM ATTACKS

**SA** – An estimated 40,000 bikers gathered at the Union Buildings in Pretoria on Saturday 29 August, to take a stand against farm attacks. White crosses, some of which contained the names of farmers who had been murdered, and flowers were placed at the entrance of the buildings.

Farmers are fed up with living in fear and protesters demanded improved police security and better prosecution rates for crimes relating to farm attacks. According to police statistics, 49 murders on farms and smallholdings were committed during the 2019/2020 financial year.

This protest follows a string of attacks where farmers, farmworkers and residents living on smallholdings in the Hartbeespoort became the target of a gang of attackers.

Police spokesperson colonel Adèle Myburgh confirmed that a gang consisting of an estimated seven suspects is active in the Hartbeespoortdam area and that they focus on smallholdings.

The first attack occurred on Tuesday 25 August at about 20:30. A family was inside their home on a smallholding in Leuwenskloof, Hartbeeshoek when their house was pelted with stones. Luckily because of the burglar bars, the suspects did not gain access into the house but caused an estimated R10,000 worth of damage. A security company was alerted and swiftly attended to the scene. On their arrival, the suspects fled the scene. A case of malicious damage to property is under investigation.

On the same night, at about 22:10, a 30-year old victim was allegedly asleep in her room on a smallholding in Skeerpoort with her boyfriend. She went to an outside bathroom but on her return to her room, was overpowered by a group of suspects, who pepper sprayed her. The attackers broke the door

of the house open to gain access. Cellphones were stolen during the incident. Police are investigating a house robbery.

In the early hours of 26 August at about 02:00, at another smallholding in Skeerpoort, a 49-year-old victim was allegedly sleeping in his room at a compound when his door was kicked open. He was assaulted with a knife and an iron rod, injuring his legs. Cash, a radio and a cellular phone were stolen. His neighbours in the compound were also robbed of their money, electrical equipment and cellular phones. Police are investigating a case of house robbery.

Later that evening at about 18:00 on a smallholding on Skuilkloof road, a 37-year-old woman, a 20-year-old woman and three boys aged 10, 5 and 4, were inside their house when they were surprised by intruders.

According to colonel Adèle the suspects entered through the kitchen. The 37-year-old woman were allegedly assaulted, and the suspects stole clothing, shoes, electrical equipment and jewellery. They fled the scene in the victim's Kia Sportage.

The victims ran to a nearby house that is still under construction to hide. The oldest boy then ran off barefoot, to a neighbour's house who called for help. The stolen vehicle was found about 300m from the house where it was involved in a minor collision with an electrical fence. A case of house robbery is being investigated.

# GROOT MARICO FARM ATTACK

POLICE LINE DO NOT CROSS

**Groot Marico** – Five armed men attacked a farmer, his wife, their elderly father and two farm workers on a farm near Groot Marico on Wednesday 2 September.

According to police spokesperson captain Aafje Botma, the attackers arrived on the farm on the Nooitgedagt road and overpowered the farmworker and his wife, and held them at gunpoint to gain access to the house. Once

they entered, they tied up the farmer, his wife and their elderly father. They were unable to open the safe and fled the scene with a bakkie and cellphones. The elderly man was the only one who sustained injuries - with minor injuries to his face.

Local farmers and police searched the area but only found the abandoned bakkie in the veld nearby. No arrests have been made as yet.

## BABY'S BODY DUMPED LIKE TRASH

**Rustenburg** – A passerby discovered the body of a newborn baby in the middle of the road, close to the corner of Molen Street and Bethlehem Drive in Rustenburg during the early morning hours of Thursday 3 September.

As news filtered through about the gruesome discovery, neighbours and members of the community rushed to the scene in disbelief.

Police and paramedics were already on the scene when Platinum Weekly arrived. "We are all very shocked. I do not understand why a person could do such a terrible thing to an innocent child, there are so many options available if you do not want to keep your child," a local community member said.



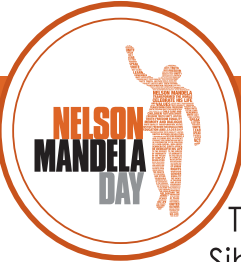
## SUPPORTING EARLY CHILDHOOD EDUCATION

IPV can take many forms, including physical, verbal, emotional, economic and sexual abuse.

**The different types of violence that form part of intimate partner violence:**

- Physical violence is when a person hurts or tries to hurt a partner by hitting, kicking, or using another type of physical force.
- **Sexual violence** is forcing or attempting to force a partner to take part in a sex act, sexual touching, or a non-physical sexual event (for example sexting) when the partner does not or cannot consent.
- **Stalking** is a pattern of repeated, unwanted attention and contact by a partner that causes fear or concern for one’s safety or the safety of someone close to the victim.
- **Psychological aggression** is the use of verbal

and non-verbal communication with the intent to harm another person mentally or emotionally and/or to exert control over another person.

**Look out for these types of behaviour:**

- Using physical aggression.
- Regular jealous, suspicious, and/or angry behaviour from partners – even if they have no reason to be.
- A person controlling their partner’s time.
- A person controlling their partner’s money.
- Using verbal threats.
- Isolating their partner.

**RE: IMPALA PLATINUM RUSTENBURG OPERATIONS’ COMMUNICATION LETTER TO STAKEHOLDERS AND COMMUNITIES REGARDING THE 2ND GENERATION SOCIAL AND LABOUR PLAN MINE COMMUNITY PROJECTS**

**1. History of the Social and Labour Plan 2nd Generation Submission:**  
The Section 102 amendment of the Impala Platinum Limited (Impala) 2nd generation Social and Labour Plan (SLP 2) document relating to the Impala Platinum Rustenburg Operations was submitted on 5 October 2018 to the Department of Minerals Resources and Energy (DMRE), North West Region, in compliance with the Mineral and Petroleum Resources Development Act, 2002. On 16 March 2020, the DMRE emailed a letter dated 12 March 2020 to Impala requesting the submission of further proof of consultation with affected stakeholders and communities (i.e. Lefaragatlhe; Luka-Mogono; and Freedom-park) for the DMRE to process the Section 102 SLP 2 amendment application.

**2. Purpose of this communication letter:**  
Impala has appointed Umsizi Sustainable Social Solutions (Umsizi), an independent and experienced specialist organisation, to assist in facilitating broad based consultation processes with Community Stakeholders for the Impala SLP 2 Section 102 amendment application relating to the extension of the implementation and completion dates of the SLP 2 Local Economic Development (LED) section. Due to the Covid-19 restrictions on gatherings during the initial lockdown period, as well as during the Lockdown Levels 4 and 3, it was not possible for Impala to continue with the required public participation consultation process.

Impala has been granted an extension by the DMRE for undertaking the required engagements and submission of a “Stakeholder Consultation Report” in support of the Impala SLP 2 Section 102 amendment application.

Hence, the purpose of this letter is to inform interested and affected stakeholders and communities of Impala’s plan and process for undertaking engagements with broader community stakeholders, in compliance with Lockdown Level 2 Regulations and stringent Covid-19 health and safety protocols (as may be amended from time to time during the Covid-19 national state of disaster period).

**3. Scope of the engagements:**  
During the engagements, the delays and progress status in the implementation of the following SLP 2 LED projects will be discussed:

- i. Luka Water Project
- ii. Kanana – Construction of Multi-Purpose Centre and Library
- iii. Mogono – Renovation of Community Hall
- iv. Lefaragatlhe - Construction of Sport Facility
- v. Freedom Park - Clinic Construction
- vi. Freedom Park - Sports Facility Construction
- vii. Freedom Park - Infrastructure upgrade
- viii. Luka/Mogono - Construction of Recreational and Sport Facilities

It should be noted that due to the Covid-19 lockdown regulations, the implementation and completion dates of the Impala SLP 2 LED projects has been further delayed beyond the current SLP 2 Section 102 amendment application date of 31 December 2020. The public participation consultation process will therefore include engagement with the interested and affected parties relating to the further extended completion date of 30 June 2021 which will support a further SLP 2 amendment application to be submitted by Impala during the course of October / November 2020 to the DMRE, North West for approval.

**4. Engagement Approach:**  
Umsizi will apply the following approaches for engagement with Community Stakeholders on their feedback and inputs into SLP 2 LED projects:

- 1. Remote means:** Telephone calls, virtual meetings (e.g. through Skype, Zoom or MS Teams), advertisements in the local newspapers, and one-on-one correspondence with stakeholders.
- 2. Physical meetings:** Face-to-face meetings with focused stakeholder groups representative of the broader communities, in compliance with Lockdown Level 2 restrictions, and with strict Covid-19 health and safety protocols observed.

**5. Impala Community Stakeholder Engagement Plan:**

- **August-September 2020** – Direct engagements already begun in the beginning of August, and further engagements with interested stakeholders will be undertaken in September. Umsizi will undertake engagements on the Impala SLP 2 LED projects, disseminating project status information and collating the inputs / feedback from the broader community stakeholders.
- **Mid-October-2020** – The inputs and feedback of community stakeholders will be written up into a “Impala 2nd Generation LED Projects Community Stakeholder Consultation Report” and submitted to the DMRE.
- The DMRE will make a record of decision on the Section 102 amendment to the Impala 2nd Generation SLP based on the submission of the report, as well as a further Impala SLP 2 amendment application to be submitted October/November 2020.

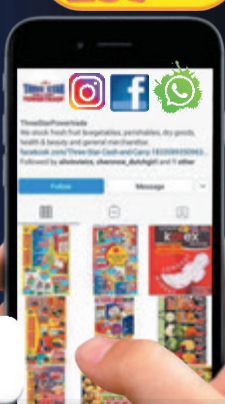

# VELD FIRES THREATEN HOMES IN RUSTENBURG



**Rustenburg** – Because of an increase in the number of veld fires in Rustenburg and Brits recently Fidelity ADT branch manager Maurice Malan urges all residents to be extra careful. “The dry, windy weather fuels fires in the veld next to properties and we have seen incidents where properties were threatened,” he says. “It is very important to ensure you are fire ready should the unexpected occur.”

He adds that when officers respond to the scene of a fire, more often than not, there are no smoke detectors or fire extinguishers at the premises. While there seems to be a shift towards greater fire prevention measures being put in place in homes and businesses, more still needs to be done.

“Installing smoke alarms isn’t common practice in South Africa – but it should be. Linked to an armed response service, you’ll have peace of mind that help is on the way in the event of a fire emergency, when every second counts,” he says. “We are in a high danger period for fires so please consider these important do’s and don’ts,” says Malan.

**FIDELITY ADT’S DO’S AND DON’T’S:**

**DO:**

- Install smoke alarms and have them linked to your alarm system.

**DON’T:**

- Buy at least one fire extinguisher for your home.
- Know your emergency numbers and what to do in an emergency.
- Check electrical cables for faults and take note of warnings on electrical appliances.
- Keep low when exiting a smoke-filled room and cover your nose and mouth with a damp cloth.
- Work out an emergency fire drill with your family.
- Leave a burning candle, heater, pot of oil or fire unattended – ever!
- Pack up your personal belongings before getting to safety.
- Try to put an oil fire out with water.
- Open a door which is hot to the touch.
- Go back into the house if you have made it outside safely.
- Go into a room that is on fire.

“Fire safety is complex but there are certain basic concepts that help prevent the start and spread of fires. Fires can be deadly and devastating. We encourage everyone to spend a bit of time thinking about fire prevention and taking steps to ensure their loved ones are protected,” he concludes.

**South Africa** – Firmer oil prices were stronger than a losing Rand, meaning that South Africans will pay less for most fuel in September. This is according to the Automobile Association (AA), commenting on unaudited month-end fuel price data released by the Central Energy Fund.  
The Association says the retreat in oil prices means that 95 octane petrol is expected to drop by around 4c a litre, with diesel down by 19c and illuminating paraffin by 24c. The only fuel typeset for an increase, is 93 octane petrol, which will climb by about 6c a litre.

# LARRIES VIER HUL 99STE BESTAANSJAAR

**Rustenburg** – Dit was die jaar 1873. President Burgers wat 'n kort tyd regeer het, maar hom met baie dinge bemoei het in daardie tyd, het die eerste botaniese tuin in Transvaal geproklameer en wel in Rustenburg.

Gedurende dieselfde jaar is 'n stuk grond, effens meer as vier morges groot, suid-oos van die destydse dorp wat uit 'n paar huise bestaan het, afgesonder as 'n botaniese tuin omdat daar sulke mooi wilde-plantegroei, maroelas, wag-'n-bietjie-, blinkblaar- en ander bome gestaan het.

Aan die begin het dit die naam gedra van Mariapark, vernoem na die predikantsvrou wat besondere dienste aan die gemeenskap gelever het. Later het die naam in onmin verval en is die stuk grond 'Het Kruidkundige Tuin' genoem. Hierdie stuk grond is later, toe die opmetings van dorpsgebiede gedoen is, deur die owerhede opsy gesit vir opvoedkundige doeleindes. Dit is hier waar Laerskool Rustenburg later gebou is en op 31 Augustus 1921 amptelik deur die Administrateur van Transvaal geopen is. Niemand weet of die opening met 'n funksie gepaard gegaan het nie en dit lyk ook nie so nie. Sedert die gebou in 1921 betrek is, was daar slegs sewe skoolhoofde naamlik:

- Mnr. Bertie Herholdt (1921-1944)
- Mnr. J le Grange (1944-1964)
- Mnr. BJ Erasmus (1964-1974)
- Mnr. Kirsten (1974-1987)
- Mnr. B Mostert (1988-1998)
- Mnr. JF J van Vuuren (1999-2003)
- Mnr. J Geldenhuys (2004-2006) en sedert 2006
- Mnr. JF Jansen van Vuuren wat tans die hoof is

In die dae van Mnr. Herholdt was vervoer skooltoe slegs met perde, fietse, of donkie- en perdekarre. In die skadu van die ou wilde-plantegroei reg voor die skool oorkant die straat, wat vandag nog daar staan, reg voor die saal en links langs die skool, het die 'goewermentsdonkies' deur die dag gerus en geduldig gestaan en wag, terwyl die kinders geleer het, om hulle smidde weer huius toe te neem.

In 1944, net voor die Tweede Wêreldoorlog beëindig is tree Mnr. Herholdt uit en Mnr. Le Grange volg hom op as skoolhoof.

Soos die skool se behoeftes gegroei het, is nog grond bygevoeg van die staatsgrond wat vroeër vir onderwys geoormerk is, en in 1940, 1955, 1958 en 1967 is daar grond tot die skoolterrein bygevoeg. 'n Personeelkamer, kunskamer en biblioteek is later aangebou, en op 7 Desember word die hoeksteen van

die saal deur Mnr. Le Grange onthul. Die saal het die ou sinksaal wat deur die ouers self opgerig is, vervang. Aan die einde van 1963 tree Mnr. Le Grange uit en 'n nuwe hoof moes aangestel word. In 1964 is Mnr. Erasmus aangestel tot 1974 en in hierdie tyd is nog 'n stuk grond aan die skool geskenk waarop die huidige pawiljoen, rugbyveld en atletiekbaan gebou is, nadat 'n bedrag van R30,000 vir die doel ingesamel is. 'n Pragtige swembad wat reeds in 1941 deur die inspekteurs in vooruitsig gestel is, word toe ook gebou, terwyl tennisbane ook tot die leerlinge se beskikking gestel is.

Drie ander laerskole het van Laerskool Rustenburg afgestig, naamlik Noordskool, Laerskool David Brink en Fields Primary. Laerskool Rustenburg word dan tereg as die moederskool van Rustenburg beskou. Oor die jare heen het die skool verskeie mense opgelewer wat groot hoogtes bereik het. Van die kinders wat later uitgestyg het, was daar belangrike leiers op verskeie terreine van die samelewing en vandag is die skool nog steeds 'n sentrum van uitnemendheid waar kinders onderrig ontvang ter voorbereiding vir hul toekoms.

# CALL FOR SUBMISSIONS

## NATIONAL ENVIRONMENTAL MANAGEMENT LAWS AMENDMENT BILL [B 14D – 2017] & NATIONAL FORESTS AMENDMENT BIL [B11 – 2016]

The Portfolio Committee on Economic Development, Environment, Tourism, Agriculture and Rural Development was briefed by the NCOP Permanent Delegate and the Department of Environment, Forestry & Fisheries on the; National Environmental Management Laws Amendment Bill [B14 D – 2017] and the National Forests Amendment Bill [B11 – 2016] on 5 August 2020.

### NATIONAL ENVIRONMENTAL MANAGEMENT LAWS AMENDMENT BILL [B 14D – 2017]

The National Environmental Management Act, 1998 (Act No. 17 of 1998) (NEMA) is the overarching umbrella legislation for environment in the country. Under this umbrella Act there are the specific environmental management Acts (SEMA), which deal with specific aspects of the environment, namely air, biodiversity, coasts, protected areas and waste in more detail. NEMA is implemented by 11 competent authorities, DEFF, 9 provinces and the Department of Mineral Resources and Energy. The National Environmental Laws Amendment Bill [B14-2017] (NEMLA) was introduced to Parliament in May 2017. The D version of the Bill was passed by the National Assembly in November 2018.

In light of the COVID19 pandemic the Committee is unable to embark on Public Hearings throughout the province.

### NATIONAL ENVIRONMENTAL MANAGEMENT LAWS AMENDMENT BILL [B 14D – 2017]

The Bill seeks to amend the National Forests Act, 1998, so as to provide for clear definitions of natural forests and woodlands; to provide for public trusteeship of the nation's forestry resources; to increase the promotion and enforcement of sustainable forest management; to increase the measures provided for in the Act to control and remedy deforestation; to provide for appeals against decisions taken under delegated powers and duties; to reinforce offences and penalties; and to provide for matter connected therewith.

In light of the COVID19 pandemic the Committee is unable to embark on Public Hearings throughout the province.
