Rustenburg – “I can’t feel my legs. They don’t want to move,” Anton Muller (78) called out to his wife as she ran to his aid.



He went outside to take his monthly photo of the municipal water meter and to lock the gate, as the Mullers were getting ready to settle in for the night.

Anton and his wife Anna have been Geelhoutpark residents since 1983. It was a late on a relaxing but chilly Saturday afternoon, shortly after a light breeze of rain at around 18h00 on 4 December. Being attacked was the last thing on their mind. Two men overpowered Anton from behind and stabbed him in his back.

Reliving the moment, Anna told *Platinum Weekly*: “I heard someone shouting and my heart sank!” My neighbours rushed to my front door yelling that Anton was stabbed and unable to get up.

Illegal connections and another protest



Traffic was disrupted along the R510 Road in Boitekong because of the protest.

Boitekong/ Rustenburg – Residents of Boitekong Extension 4 in Rustenburg took to the streets during the evening hours of Saturday 4 December to protest the shortage of water in the area, blocking the R510 Road in Boitekong.

Rustenburg Local Municipality (RLM) spokesperson Thapelo Matebesi said water supply was eventually restored after councillor Thabang Rampou – the member of the mayoral committee (MMC) responsible for Technical and Infrastructure – intervened.

Matebesi said the shortage was caused by an illegal connection to the electricity box supplying the actuator valve.

He said personnel from the municipality's bulk team managed to remove the illegal connections and restored water supply to the affected areas.

"We are pleading with residents to avoid tampering with municipal infrastructure services. We also urge residents to use water sparingly," Matebesi added.

Left in the dark



Streets were blocked off with burning tyres.

Rustenburg – East End residents took to the streets to voice their anger at the lack of electricity on Wednesday 8 December. The power went off on Saturday 4 December and after five days without electricity, several residents set tyres alight in the street hoping the Rustenburg Local Municipality will finally pay attention to their challenges.

Later that evening, the electricity was restored... for a full 10 minutes.

"I first reported the problem on Saturday 4 December. At that time, much larger areas also experienced outages. When the electricity tripped just before midnight on the same day, I reported it again," said Democratic Alliance ward 18 councillor Cobus Cronje.

"I understand our community's frustrations, but damaging roads and lighting tyres will solve nothing," he added.

At the time of going to print, only two houses were still without electricity.

SERIAL RAPIST GETS 65 YEARS BEHIND BARS

Phokeng/ Rustenburg – A serial rapist that prowled the streets of Phokeng from 2010 to 2013 at night looking for his next victim, was arrested and successfully convicted.

His modus operandi was to threaten young women aged 15 to 30 at gunpoint, force them into the bushes and then rape them. He would then rob them of their valuables and leave them for dead. Tshepo Ben Moloi (42) was sentenced a 65-year jail term on Monday 29 November before the Bafokeng Regional Court in Tlhabane on five counts of rape, five counts of robbery and escaping from lawful custody. Some of the charges will run concurrently. “Moloi accosted his victims late at night or during the early morning hours,” says police spokesperson colonel Aafje Botma. Moloi’s first documented rape was of a young woman a day after Christmas in 2010. His second, a 15-year-old girl on New Year’s Day in 2011...

Moloi was finally traced and arrested, but he escaped from police cells. “He was re-arrested two days later on 29 December 2013 at a smallholding in Kroondal after we received a tip-off. He was in police detention until he was positively linked to the rape incidents through DNA matches,” Botma confirmed.

The firearm used by Moloi to threaten his victims with, has not yet been recovered by the police.

“Never walk alone at night,” warned police spokesperson in Rustenburg captain Elsabe Augustides. “Observe your surroundings and carry a whistle that you can blow if you need assistance.”

“He must have looked like an easy target, cellphone in the hand and unaware of the opportunist criminals on the prowl,” Anna said. They fled the scene on foot with his cellphone. “We have a Rustenburg Crime Combatting Forum (RCCF) board on our gate. I immediately phoned them, in a panic. Within minutes, they arrived and started searching for the attackers.” Unfortunately, they got away.

At the time, Anton couldn’t feel or move his legs. It was an emotional time, not knowing what the outcome of his injuries would lead to. He was rushed to Medicare Hospital.

“My husband is very safety-conscious about using cell phones in public areas. He doesn’t like anyone taking using their phones in public – not even in the mall. But you never think that something like this will happen to you just outside your own gate.”

By grace, Anton is alive and well and getting better by the hour – and in good spirits. He sustained no serious injuries to his spine where he was stabbed. Immediate swelling around his spine caused the numbness in his legs.

“We thank God for sparing Anton and that He sent all these amazing people to us in our time of need. The RCCF went out of their way to find the attackers. Our neighbours, our pastor and people from our community prayed with us for his recovery and gave us so much support. We are truly blessed,” Anna said.

Woman hires gunmen to kill husband

Mooinooi – A 41-year-old woman from Mooinooi, who confessed to killing her husband will spend at least 25 years behind bars. Helen Mashaba, who hired two gunmen to kill Solomon Mashaba, was handed a life sentence by the North Gauteng High Court on Monday 6 December 2021. She was arrested on 10 October 2020 after confessing to carrying out the plan to murder her husband. This was after police had been summoned to the murder scene by community members who spotted a body at Malema Section in Modderspruit near Mooinooi. “Upon arrival at the scene, they found the body of a male with three gunshot wounds in the upper body – execution style,” police spokesperson captain Aafje Botma said. “She also revealed that she hired two hitmen to kill her husband.”

Four employees fatally injured at Sibanye-Stillwater



Rustenburg – Sibanye-Stillwater reported the tragic loss of four colleagues in two separate incidents on Friday 3 December 2021.

At approximately 02h30 that morning, a colleague at Khuseleka shaft at the Rustenburg operations passed away due to a fall of ground incident which occurred while he was barring down the sidewall of a development end.

Later that morning, at approximately 10h00, three colleagues at 3 Shaft at the Beatrix operations, passed away following a tragic trackless mobile machinery incident.

The board and management of Sibanye-Stillwater extend their sincere condolences

to the families, friends, and colleagues of the deceased.

Commenting on the safety incidents, CEO Neal Froneman said: "Despite our extraordinary efforts this year, the number of fatal incidents we have experienced is of grave concern for management and the Board of Sibanye-Stillwater. We are appalled by the loss of our employees' lives at our mines over the past year. While we cannot rectify the harm that has occurred, we will continue to support the families as best we can in their grief. The safety of employees is our primary concern and we will continue to strive for zero harm in the workplace."

120 stranded after flood

Rustenburg – A coordinated effort by the Rustenburg Local Municipality (RLM) disaster management unit, the South African Social Security Agency (SASSA) and Al-Imdaad Foundation assisted Monnakato residents whose homes were destroyed by a recent flash flood.

More than 120 people in Monnakato were stranded after Thursday 4 December's pouring rainfall.



RLM councillor Happy Serongwane responded quickly and mobilised support. "The residents were provided with salvage kits and food parcels," RLM spokesperson Thapelo Matebesi said.

"We have also applied to the Department of Human Settlements to help by availing funds from the Disaster and Emergency Relief Grant so that the affected families can be further assisted," Matebesi added.

Damaged roads under repair

Tlhabane/ Rustenburg – The Rustenburg Local Municipality (RLM) has engaged the services of a local company to repair damaged roads in ward 9, 10 and 11, Tlhabane.

The company, NTRR Engineering Projects, has been patching up potholes on roads that were seriously damaged by the heavy rainfall that pounded Rustenburg in recent weeks.

RLM Member of the Mayoral Committee (MMC) for Roads and Transportation councillor Lebogang Pule said the contractor was appointed two weeks ago. The company – which was formed in 2005 – has employed 15 local workers (five from each of the three wards in

Tlhabane) to carry out the repairs.

On Wednesday 8 December, *Platinum Weekly* caught up with one of the company's teams at a busy intersection along Motsatsi Street.

They were removing damaged tar and resurfacing a badly damaged portion of the road while a woman was diverting traffic to an alternative route.

"We started repairing the roads in Tlhabane on Tuesday 7 December," one of the workers commented. "There are specific spots that we have been tasked to repair and it is very likely that if we experience more heavy rainfall, we will continue with our work during the beginning of January 2022," he added.



Classic Oriental Consultancy in partnership with Ubank and several local stakeholders joined hands to renovate Tsholetsa Disability Centre on Friday 3 December.


