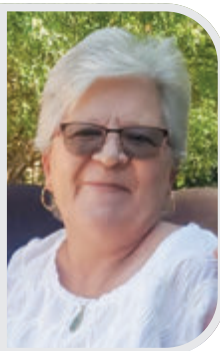

MURDER SUSPECT ARRESTED

Rustenburg – A swift investigation by the Phokeng detective's unit has led to the arrest of a murder suspect. According to colonel Adèle Myburgh, 34-year-old Joseph Ramokotjo Moeketsi was allegedly gunned down on the evening of Sunday, 23 March 2025, outside a popular bar and restaurant in Freedom Park. Thabiso Ntwana (40) was swiftly identified and arrested for the murder. He made his first court appearance on Tuesday, 25 March 2025, at the Bafokeng Magistrates' Court in Tlhabane, where he was remanded in custody.



BETRAYED BY BLOOD: COUSIN GETS 15 YEARS FOR RAPE

Mogwase – A 34-year-old man was sentenced to 15 years of direct imprisonment on Tuesday, 25 March 2025, for the rape of his own cousin. The Mogwase Magistrates' Court handed down the sentence, marking a strong stance against gender-based violence. The incident occurred on Sunday, 8 October 2023, when the victim, then aged 29, was socialising with her cousin and a friend. The three were enjoying drinks together when the friend requested to be taken home. The perpetrator offered a lift in his vehicle. Tragically, the victim — unaware of what was to follow — fell asleep in the back seat. Instead of ensuring her safe return, her cousin diverted to a secluded bushy area in Bojating, Mogwase, where he committed the unthinkable act. Constable Balungile Makaya of the Mogwase Family Violence, Child Protection and Sexual Offences Unit (FCS) led the investigation, ensuring justice was pursued with diligence and care. Working closely with prosecutor Sicelo Moselakgomo, the team built a solid case that led to the successful conviction. Acting provincial police commissioner of North West, major general Patrick Asaneng, praised the teamwork that secured the outcome.

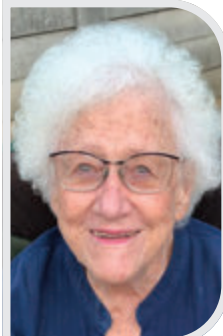

Rustenburg – What began as a noble idea to support each other financially has ended in criminal charges, missing money, and the bitter sting of betrayal for members of the Mpheni Social Club — a stokvel created by employees of the Rustenburg Local Municipality.

Two senior municipal officials, Benjamin Mathews Mogotsi (51) and Constance Motaung (50), appeared in the Specialised Commercial Crimes Court in Mmabatho sitting in Rustenburg on Wednesday, 27 March 2025. The pair face four counts of fraud relating to the alleged theft of over R600,000 from the social club's account. The case has been postponed to 29 May 2025 to allow for its transfer to the Commercial Crimes Court in Rustenburg.

MOOINOOI ROBBERY SPREE BROUGHT TO A HALT

Mooינווי – In a win for justice, a 19-year-old suspect linked to a string of robberies in Mooינווי has been arrested thanks to crime intelligence and teamwork by the South African Police Service (SAPS). The suspect, Amogelang Mashaba, was apprehended on Sunday, 23 March 2025. Acting on a warrant of arrest and after sustained observation, officers moved in to arrest Mashaba, bringing an end to months of investigations. According to SAPS spokesperson, colonel Ad le Myburgh, further investigation revealed that Mashaba is allegedly connected to five criminal cases, including three armed robberies and other serious offenses:

1. **Armed robbery** – Wednesday, 26 July 2023
2. **Possession of suspected stolen property** – Wednesday, 26 July 2023
3. **Armed robbery** – Friday, 28 July 2023
4. **Armed robbery** – Sunday, 18 August 2024
5. **Common assault** – Monday, 27 January 2025

Mashaba made his first appearance at the Brits Magistrates' Court on Wednesday, 26 March 2025. He was remanded in custody and is set to reappear on Friday, 4 April 2025. The acting provincial police commissioner, major general Patrick Asaneng, commended the officers involved.



Rustenburg officials in hot water over R600K stokvel scandal

According to information presented in court, the Mpheni Social Club was formed by municipal employees as a savings initiative where members contributed money monthly, with the understanding that these funds would be shared among them at the end of the year. Mogotsi was elected as chairperson, while Motaung served as the treasurer. But between 25 and 29 November 2023, something went terribly wrong. Funds reportedly vanished from the club's bank account — without the permission or knowledge of the other members. It later emerged that Mogotsi and Motaung, both signatories on the account, had allegedly withdrawn the money and invested it in cryptocurrency, resulting in a complete loss. The alarm was first raised by the treasurer, who noticed the suspicious withdrawals. Following a report by the secretary to the police, the matter was escalated to the Provincial Commercial Crime Investigation Unit, and after thorough investigation, a warrant of arrest was issued. The suspects were taken into custody on Wednesday, 26 March 2025. In court, the state did not oppose bail, citing that the accused were not flight risks, but requested stringent bail conditions. The court granted each accused bail of R5,000, on condition that they surrender their passports. The acting provincial commissioner of North West, major general Patrick Asaneng, has welcomed the arrests and applauded all role players for their swift and coordinated response.

Beyond Awareness

Making Water Conservation Education Actionable

We must move beyond telling people what to do and instead help them understand why water conservation matters — personally, economically, and socially.

BRUTAL ATTACKER GETS 21 YEARS BEHIND BARS

Rustenburg – A year to the day after a heinous early-morning stabbing left a security guard fighting for his life, justice was finally served. On 31 March 2025, the Tlhabane Regional Court sentenced Alberto Cossa (29), a Mozambican national, to 21 years in prison — 20 years for attempted murder and an additional year for being in the country illegally. The crime, described as “brutal and senseless,” took place in the early hours of 31 March 2024, in Damooiview, Boitekong, when a local security officer was ambushed and stabbed in the stomach, exposing his intestines. The victim was on his way to work at approximately 04:00. According to sergeant Ofentse Mokgadi, a quick-thinking neighbour used his jacket to contain the victim’s wounds, likely saving his life. The man was rushed to

hospital, underwent emergency surgery, and spent 16 days under medical care. Medical experts testified during the trial that the attack could have been fatal. The prosecution, led by advocate Zola Mpayiphelli, presented a strong case, securing the maximum possible sentence due to the savage nature of the crime. Detective sergeant Karabo Monyatsi, who handled the investigation, was praised for his relentless efforts in building a solid case. The accused had been in custody since the day of the incident, and bail was denied throughout the legal process. Importantly, the sentences handed down will not run concurrently. Cossa will serve 20 years for attempted murder, followed by an additional year for his illegal presence in the country. Upon completing his time, he will be deported to Mozambique and is now declared unfit to possess a firearm.

Makwassie Incident Raises Concerns Among Farming Community

Makwassie, North West – Bennie Kanes, a farmer from Makwassie, was recently ambushed at the gate of his farm of which he took legal ownership in September last year. His farm is currently being occupied without his consent. Speaking to *Platinum Weekly*, Kanes expressed concern about the growing number of farm security incidents in farming communities across the country. “This is not good for the farming community,” he said, adding that the situation is becoming increasingly volatile. Kanes noted he had seen a video of another farmer reportedly arrested for employing two undocumented Zimbabwean nationals, and the nature of the video, in which the female police officer called the white farmer a ‘racist’ was extremely distasteful, especially against the backdrop of South Africa’s strained relations with the United States. His own journey with the Makwassie farm began when he viewed the property with the previous owners as a prospective buyer. At the time, he noticed three individuals on site but assumed they were workers. Before he purchased the farm, Kanes learned that the occupants were former tenants who had failed to pay rent, reportedly falling into arrears of about R300,000. The rental contract was then through legal processes cancelled by the previous property owner, after which the people asked to buy the property. However, after receiving a purchase contract, they never signed the sales contract or paid the required funds. After several formal notices were issued through attorneys, the tenants were informed that the property would be sold to another buyer. Kanes signed a purchase agreement at the end of March 2024, and after paying in full, the property was officially transferred to his name on 4 September 2024. As per the contract, he was granted occupational rights immediately after paying the deposit. When he arrived to inspect the property and plan necessary renovations, he found the occupants still on-site. They told him they had planted sunflowers, and Kanes allowed them to stay

temporarily to harvest the crop. They agreed to vacate the farm thereafter. However, on 14 February 2025, the current occupants applied—unsuccessfully—to the High Court for a protection order to restrict Kanes’ access to his own property. The situation escalated further on Human Rights Day, 21 March 2025. Around noon, Kanes and a friend were ambushed at the farm gate by a group of individuals associated with the Bathlame cooperative. As he exited his vehicle to open the gate, a truck blocked him from the front while a tractor pulled in behind, effectively boxing him in. Seven men physically assaulted him. During the altercation, one attempted to grab a large knife from inside Kanes’ vehicle, but he managed to intervene and throw it away. A video of the incident was later posted on TikTok, accompanied by racially charged messages, including: “The war has begun at the Makwassie farm. We want our land back. I’m ready for war.” Kanes believes his friend’s calm demeanour during the incident may have helped de-escalate the confrontation, as some attackers may have suspected they were armed. Local police responded quickly after Kanes called for help, and the situation was stabilised. He has since laid criminal charges and hopes that law enforcement will help restore his full access to his property. “I trust that the SAPS will accompany me and help bring order peacefully,” he said. A seasoned farmer, Kanes has spent decades working hard to build a future for his children and grandchildren. Despite the uncertainty and tension, he remains grounded in his faith. “Looking back, I realise that God protected me that day. I continue to pray for His protection and for a peaceful, sustainable resolution.” Farmers in the area have expressed growing concern about the rise in tensions and the divisive language being spread on social media. Many, like Kanes, are hoping for a return to order and mutual respect under the law.

Separate incident at Bosparadys Dairy farm | Arrests at Bosparadys Spark Controversy and Public Debate

Videos and photos of the arrests made by SAPS at Bosparadys spread like wildfire—primarily because a white farmer and a white HR manager were arrested alongside two Zimbabwean foreign nationals who were allegedly working at the dairy farm without proper documentation. Given the current political climate and ongoing media coverage surrounding Afrikaners and white farmers in particular, the footage quickly became a major talking point across social media and communities. In one of the videos, a female SAPS officer can be heard calling the white male—who was being loaded into the back of a police van—a “racist.” Meanwhile, several Facebook and YouTube posts related to the incident have since been removed from the web. According to online sources, a land claim was filed against the Bosparadys farm several years ago, although the exact date remains unknown. THE PARLIAMENTARY COMMUNICATION SERVICES ON BEHALF OF THE CHAIRPERSON OF THE PORTFOLIO COMMITTEE ON EMPLOYMENT AND LABOUR, MR BOYCE MANELI said in a statement that the Bosparadys Dairy Farm arrests are not in isolation from other arrests of non-compliance. “There is no witch-hunt against a particular race or national group as communicated by some in the social media platforms recently spreading and mobilising on falsehood narrative. The employer and the undocumented foreign national who were in the same police vehicle were arrested for contravention of the laws of this country. All shall be equal before the law has been given meaning in this case.” In its October 2024 oversight programme, the committee witnessed the arrest of employers and undocumented foreign national employees at Country Mushrooms Farm in Pretoria. Nichol Muller has been the managing director of Country Mushrooms since 2009. This company has been growing high-quality mushrooms since 1996. The Portfolio Committee on Employment and Labour wrapped up its week-long oversight visit in the North West Province. The oversight programme prioritised high-risk areas in the Bojanala District and surrounding areas for unannounced Department of Employment and Labour inspections, focusing on compliance with Basic Conditions of Employment Act (BCEA), Unemployment Insurance Act (UIA), National Minimum wage Act (NMWA) and Occupational Health and Safety (OHS) including direct engagement with employers and workers through walkabout. They visited the Mahikeng-based North West Boerdery farm on Tuesday, 25 March 2025. Jacques Cronje of North West Boerdery heads a weekly livestock auction. Then they visited Bosparadys Dairy on Wednesday, 26 March. That is where the talked about video was taken. The committee further conducted unannounced inspections in the hospitality industry at Sun City focusing on Sun City International and Day to Day Farm in Rustenburg on Friday, 28 March 2025. The committee noted with concern the absence of the Department of Home Affairs in these two inspections at Sun City International and Day to Day Farm where the enforcement of the immigration laws is required.

The Outcomes of Current Government Policies Regarding Zimbabweans in South Africa

The estimated number of Zimbabweans living in South Africa varies depending on the source, with most estimates ranging between 1.6 and 3 million. Many migrants may have initially entered the country legally but overstayed their three-month passport stamp, thus becoming undocumented. Additionally, thousands cross the border into South Africa without any documentation at all. The South African government’s approach to the means of subsistence for Zimbabwean migrants has evolved over time, primarily through the implementation of special permits designed to legalize their stay and grant them the right to work. Currently, it is estimated that around 160,000 Zimbabweans hold valid permits. It was also announced on 2 April 2025, that approximately 46,000 undocumented foreign nationals were deported during the 2024/2025 financial year. An overwhelming 99.99% of Zimbabweans entering South Africa do so in search of a better life—to support themselves and their families back home. They are human beings, just like you and me. They need money to buy food and often seek out

casual labour opportunities to survive. According to the South African Police Service (SAPS), recent arrest figures indicate that foreign nationals make up more than half of the total arrests. This raises the question: what is the logic behind these figures? The government permits a steady inflow of Zimbabweans (with passports) who often have no means of supporting themselves. Many reportedly send their passports back to the border via taxi services to get their entry stamp renewed—at a cost, of course—illustrating that bribery remains widespread in South Africa. At the same time, while the Department of Home Affairs is clamping down on employers hiring Zimbabwean nationals, the government continues to maintain an open-door policy allowing them to enter the country. The inevitable results of this contradiction will be a sharp rise in crime and an increasing number of local churches stepping in to distribute food parcels to desperate migrants. Every decision in life is outcome-based. The results we experience are the consequences of our choices and actions. Currently, this is the accepted input and outcome of South Africa’s policy decisions.

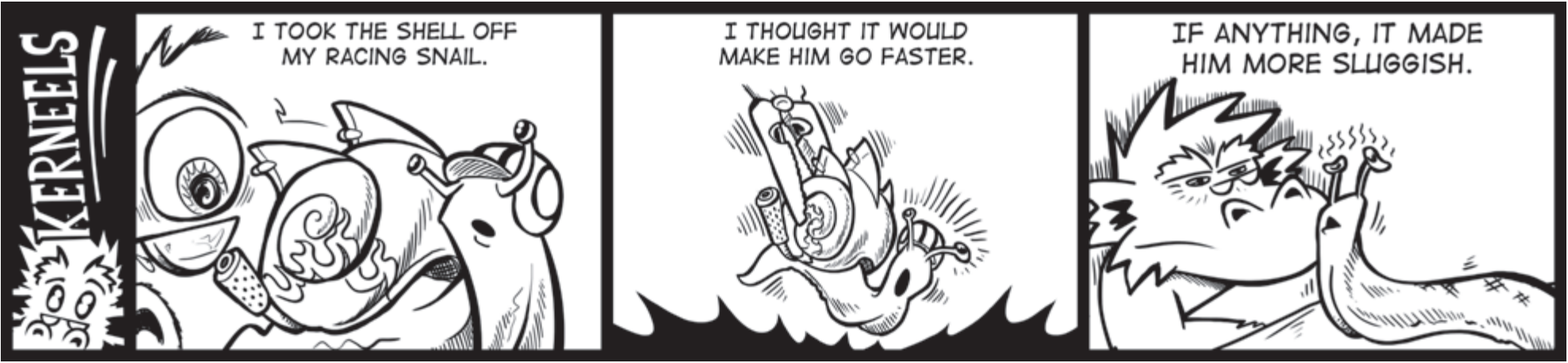

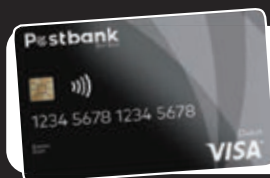
